Impact

In 2012, The Center for Drug-Free Living achieved a number of notable accomplishments.

- 1) With the aid of a Department of Veteran Affairs capital grant, The Center was able to open a brand new, residential facility for homeless female male veterans. Operation Center Focus Women is a 28-bed, transitional housing program is located Cocoa, Florida. It assists female veterans that are coping with issues including post-traumatic stress disorder, flashbacks, broken relationships and isolation and physical trauma and pain resulting from combat related injuries.
- 2) The Center, along with 6 other local behavioral health agencies, foundedCentral Florida Cares Health System, Inc. (CFCHS), a behavioral health administrative and management organization. CFCHS is the Managing Entity for all Florida Department of Children and Families Substance Abuse and Mental Health Program contract in Central Florida.
- 3) The Center was awarded several federal and state grants to expand and enhance services. They include: \$250,000 a year for 3-years from DHHS-SAMHSA-Center for Substance Abuse Treatment to expand and enhance the Orange County Family Dependency Court; \$400,000 a year for 3-years from DHHS-SAMHSA-Center for Mental Health Services trauma focused treatment services to children, adolescents and their families; 2 separate Prevention Partnership Grants from the Fla. Dept. of Children and Families to provide school-based prevention and interventions services in Orange and Seminole Counties.

Needs

The most significant challenge facing The Center for Drug-Free Living in the coming year is the "system change" that will result from the implementation of the Patient Protection and Affordable Care Act. Healthcare Reform will change the way individuals access behavioral

health services. As insurance becomes more accessible and Medicaid eligibility is expanded, the primary reimbursement mechanism for services provided by The Center will change dramatically. Service delivery, billing and record keeping will all be affected. While these

challenges are daunting, they will be met and by those individuals providing the services. The needs of those we serve will remain much as they were before:

- · Clothing, food, and transportation for individuals coping with homelessness;
- Educational, vocational and job placement assistance for adolescent and adults entering, or re-entering, the workforce;
- · Prescription medications for individuals with co-occurring disorders; and,
- Mentors and sponsors to coach and support individuals in their recovery and re-entry into mainstream society.

Background

The Center for Drug-Free Living, Inc. (The Center) is a comprehensive, community-based, behavioral health organization, which has been in operation since 1971. A tax-exempt, 501© (3) Florida corporation, The Center is licensed by the Florida Department of Children and Families and nationally accredited through the Commission on Accreditation of Rehabilitative Facilities (CARF). Program components include substance abuse education, prevention, intervention, outpatient and residential treatment, methadone maintenance treatment, detoxification, drug court, HIV overlay, outreach, education, testing and supportive services, aftercare and juvenile justice services. Children, families and their communities make healthy lifestyle choices. The Center provides prevention, intervention and treatment services to approximately 14,000 individuals. The Center serves the residents of Central Florida regardless of age, sex, creed, race or ability to pay. The Center has demonstrated a commitment to the provision of services that are consistent with all local, state and federal laws, regulatory provisions, and the organization's code of ethics. With a staff of 500 professionals, The Center is strongly committed to stopping the cycle of substance abuse and violence within our community in an effort to achieve and maintain substance-free status, make healthy lifestyle choices and to establish stable and supportive environments. In 1971, under the Orange County Health Department *Project (407)* (The Center) opened as the first drug rehabilitation center in the Central Florida area. Project 407 was incorporated as a notfor-profit organization under the name Thee Door and the agency's first major service expansion came in 1972 with the opening of the first methadone treatment program in area. In 1976 the Alpha Center opened targeting youth ages 8 – 12 who were at risk for substance abuse and delinquency. Alpha's success paved the way for expansion and today the agency provides school-based services in 3 counties to elementary, middle and highschool students. In 1982 the agency changed its name to The Center For Drug - Free Living, Inc. and developed expansions and enhancements of diversified services designed to meet the growing needs of the community. Since that time the Center has opened 3 juvenile justice rehabilitation programs and merged with CENTAUR to provide supportive services to HIV/AIDS clients across Central Florida. Over the last 42 years, The Center has gained the respect and continued support of community members and organizations across Central Florida in promoting healthy, responsible lifestyles.

CEO/Executive Director Statement

The goal to succeed is a universal one, but the ability to exceed that

goal is based on one's ability to rise to the challenge. With constant media reports of budget cuts, faltering economies, and increasing demands for services, our society has been inundated with messages of "crisis overload"; seemingly endless dilemmas lacking solid, overall solutions.

As budgets continue to shrink The Center is doing more with less. We are looking at the challenges put before us not as obstacles, but as

opportunities to grow as an organization, to improve our business practices, and to enhance our services.

Simply stated, The Center is in the business of change. Every day we

provide individuals and families across Central Florida the tools and skills needed to achieve and maintain healthy, responsible lifestyles. Now, we must take those same core principal, theories and practices of change and apply them to our daily internal operations. This year, The Center took major steps in that direction by launching a new Electronic Clinical Record system which allows for more streamlined processing of client data as well as organizational accountability. In addition, "Center Connect" a web-based treatment modality using webcam conferencing, was introduced as an option for outpatient services clients.

The face of our client population is also changing. They have more

complex issues which require new treatment methods. The Center has also responded to the need for substance abuse and mental health services for our nation's veterans by expanding our continuum of services for this continually increasing population. Recently, The Center was awarded two grants from the Department of Veteran Affairs. With these grants, The Center opened a 32-bed homeless male veteran's facility in 2011 and will open a 28-bed facility for homeless female veterans in 2012.

Ben Franklin once said, "When you're finished changing, you're

finished." For over 40 years, The Center has provided quality, evidence-based prevention and treatment services to communities across Central Florida proving that we are not finished; that we are rising to the challenge of change.

Board Chair Statement

Economic instabilities and technological advances are reshaping how we as a society and as a business operate. No longer can we rely on the systems and performances of the past. Juvenile Justice Services

Description

The Center's Juvenile Justice Residential Commitment Services provides residential care, custody and treatment services for adolescents committed to the Florida Department of Juvenile Justice. The division includes separate programs, each serving a different population.

Brevard Group Treatment Home (BGTH) – 30-bed, Low Risk program for adolescent males ages 12-15. Boys committed to the program remain in treatment for an average of 4 to 6 months. During their stay, residents attend school on site and receive individual, group and family counseling.

Francis Walker Halfway House (FWHH) – 30-bed, Moderate Risk program for adolescent females ages 13-18. Girls committed to the program remain in treatment for and average of 6 to 9 months. The program provides comprehensive gender specific programming which addresses and supports the developmental process of female adolescents. During their stay, residents attend school on site and are provided extensive health education, nutrition classes, substance abuse treatment and prevention education, CPR certification, parenting and pre-vocational skills. They also receive individual and group counseling. Attention is also placed on addressing issues of grief, domestic violence, stress, sexual abuse and substance abuse.

CENTAUR - HIV/AIDS & Hepatitis Services

Description

The mission of CENTAUR is to reduce the incidence of HIV and Hepatitis infection in our community and to improve the quality of life for persons who are infected or affected by HIV/AIDS and/or Hepatitis. Services are designed to address the factors associated with the risk or progression of infection. CENTAUR provides confidential testing; mental health counseling; community referrals; comprehensive education sessions; and substance abuse assessment & counseling. In addition, CENTAUR also provides HOPWA (Housing Opportunities for Persons with HIV/AIDS) services for those individuals infected with HIV/AIDS and are experiencing a threat of homelessness or are already homeless. Program services include short-term rental, mortgage,

and/or utility assistance for people living with HIV/AIDS and their families. In addition, facility-based housing is available, based on eligibility, for those people living with HIV/AIDS in need of substance abuse and/or mental health treatment services. In addition to being a HOPWA provider, CENTAUR is also a Ryan White provider.

Dick Jacobs holds a Masters Degree in Clinical Psychology from the University of Central Florida, is a licensed Marriage and Family Therapist, and a Certified Addictions Professional. Mr. Jacobs is an Approved Clinical Supervisor for Family Therapy in Florida and a Clinical Member of The American Association of Married and Family Therapy.

He is currently the President/CEO for The Center For Drug-Free Living (The Center) where he is responsible for the services delivery and oversight of \$30 million dollar, 500 employee organization. Ms. Hankey continues to work on many cross-cutting substance abuse and behavioral healthcare issues at the State and National levels. She is one of 11 individuals appointed to the Florida Governor's Drug Advisory Council. Ms. Hankey also was appointed to the Orange County Chairman's Jail Oversight Commission and served as the co-chair for the substance abuse and mental health subcommittee.

At the forefront of these collaborations are the Florida Departments of Children and Families, (DCF) and Juvenile Justice, (DJJ). All Substance abuse prevention, intervention and treatment services provided by The Center are licensed by DCF. The Center also works with DCF to develop appropriate rules and laws governing the provision of these services. Additionally, The Center works directly with DJJ to enhance existing services and develop new capacity.

One of the newest and most exciting collaborations is with the Department of Veterans Affairs. Through the VA's Grant and Per Diem Program, The Center is currently constructing two separate facilities to serve Homeless Veterans. The first is a 32 bed facility for men that is scheduled to open in Spring of 2010 in Orange County. The second is a 28 bed facility for women and their children that is scheduled to begin construction in Fall of 2010 in Brevard County. These services have been identified as a priority by the VA.
