A sinkhole swallowed a sizable portion of an Orange County backyard and a swimming pool Monday night, prompting the homeowner to move out for at least the night. Orange County Fire Rescue arrived at 8:30 p.m. at 2300 Roxbury Road, steps from Killarney Drive and Lake Killarney, to find the hole 40 to 50 feet wide and 30 to 40 feet deep, Battalion Chief Billy Richardson said. "They came back from dinner and half the backyard was gone," he said. The resident, identified in property records as Suzanne Blumenauer, had a pool party on Sunday and everything was fine, Richardson said.

"It's a very minimal amount of overflow compared to the amount of lake water," said Howard, adding the city doesn't want people to come in contact with the water until it's cleared.
